



Horse Owner Agreement Form

If the horse is registered with a breed registry that has its own registry symbol, you **must** present the **original** registration papers (**no photocopies**) with your name as the owner of record for the breed symbol to be applied to the horse. A transfer slip signed by the owner of record and completely filled out with the new owner's information in addition to the original papers will be accepted. ***Please be sure to check the horse's registration papers before the marking date to be sure that the horse's markings and identifying marks on the registration papers match.*** In the event that the original papers are not presented or the horse and/or owner of record do not match the registration papers, the horse cannot be marked with the breed symbol and number. At that time you will have the option of choosing to have the state symbol and number applied to the horse. If you choose not to have the state symbol and number applied to the horse, you will forfeit any deposit made. If you choose to reschedule, another marking fee will be due at that time.

The owner of the horse is expected to handle the horse or have someone present to do so. If the owner or the horse will not be present at the time of marking, the handler must present a signed "Owner and Second Party Authorization Form". If no authorization form is presented or is on file and the owner is not present, the horse **cannot** be marked. In the event that this should occur, the horse owner will forfeit any deposits made and will be liable for the entire marking fee. If the horse owner wishes to reschedule, there will be another marking fee due at that time.

The process is painless, but some horses resent having to stand still during a procedure that feels unusual. It is advised that the horse owner acquire a tranquilizer, such as Ace-Rompum mix, that the horse owner can administer, or make arrangements with their veterinarian. Kryo Kinetics USA LLC technicians are not licensed to administer medication and do not provide the service of sedation or tranquilization. This is the horse owner's responsibility. PLEASE BE ADVISED... If the behavior of the horse results in an inability to apply a mark, the marking fee will still apply. In addition, there will be an additional fee required to remark or touch-up an incomplete or non-existent mark which was the result of the horse's misbehavior at the time of marking.

Kryo Kinetics USA LLC technicians reserve the right to refuse to mark a horse that is uncontrollable, vicious or dangerous to its self, other horses or people.

I have read the above document and understand the information given. I also understand my responsibilities as the horse owner and realize that my failure to provide the necessary information or assistance as described above, may result in a forfeiture of any deposits made, as well as cause me to incur additional costs related to the freeze marking process.
